#### **8524 Minutes of the previous meetings.**

It was **resolved** that the Chairperson be authorized to sign the minutes of the Ordinary Parish Council Meeting held on 23<sup>rd</sup> February 2022 as a true and accurate record. It was noted that it was again discussed that we have applied for funding to reduce the speed limit on Lindrick Rd to 20mph.

Lindrick Golf Club, It was noted that Joanne Hudson is now working with Andrew Lee and the Clerk is to contact the Golf Club about a meeting. It was agreed that the Clerk contact RMBC to ask Google Maps to alter their route.

Business Continuity Plan, a meeting is to take place on the 7<sup>th</sup> April 2022.

Christmas Tree Lights, RMBC will be in touch in October.

Tree works, Councillor Clarke informed the meeting that approval for 8 cherry trees on Bern Square had been approved and he was waiting for approval at Dinnington Rd.

It was agreed in principle to start the process of planting small trees along the verges of Worksop Rd. It was noted that the Golf Club are cutting back a lot of trees. It was agreed to consult with the public as to where they would like to see more trees planted in the village.

Family Gardens Meeting, interest from the public seems to be waning and it was agreed to have a site meeting to discuss fencing and tree planting.

Defibrillator, process ongoing.

New Notice Board, it was agreed to have a site meeting to discuss and agree the type and size.

Planters, it was agreed to have up to 15 made up in red, white and blue to mark the Queens Jubilee.

**8529 Public Participation**

The members of the public commented on a planning application on the land Sth of Taylor Drive for 10 bungalows.

They were concerned about, loss of privacy, parking, highways, TPOs on 2 sycamores and loss of Green Belt.

They were advised to keep any objections within the confines of “Material Planning Considerations”.

**8530 To consider Events.**

It was agreed to apply for planning permission for the Jubilee Beacon, with Councillor Knight to send the clerk a map with the chosen location.

**8531 To consider the co-option of a new councillor.**

3 applicants for the casual vacancy attended the informal discussions with the councillors on Tuesday the 29<sup>th</sup> March.

A secret vote to co-opt onto the council was taken and 4 votes were for Diana King and 4 were for Thomas Williams. The vote was split so no outright majority was achieved.

The Councillors were asked if anyone wanted to change their vote and no-one did. This then led to the Chair having the casting vote and she voted for Thomas Williams to be co-opted onto the Parish Council.

It was resolved to co-opt Thomas Williams onto the Parish Council.

Thomas signed the “Eligibility Form” and joined the meeting.

RB2022/0498 Land south of Taylor Drive

It was resolved to object on the grounds that the development will have an adverse affect on the highways and parking in the area. It is also commented that the Parish Council is very disappointed that there are no environmental initiatives in the plans.
