8736 Minutes of the previous meetings.

It was resolved that the Chairperson be authorized to sign the minutes of the Ordinary Parish Council Meeting held on 20th February 2023 as a true and accurate record.

8737 To identify items which may be considered following the exclusion of press and public.

None.

8738 To consider any variations to the orders of business.

It was resolved to move Item 14 (pavilion development) to the start of the meeting.

8739 To receive new Declarations of Interest in respect of business on the Agenda.

8740 To receive information on ongoing issues.

Business Continuity plan, Emergency Plan, Parish Plan, Tree Planting, Container: It was agreed to defer these matters.

Flower Beds, some are built and the remainder will be finished in the next few weeks. Dog bins, a map of current locations has been received from RMBC and it was agreed to monitor the situation and possibly look to replace the one on Lindrick Road. Pelican Crossing, Councillor Tweed had commented to the Chair that 24 hour surveillance would be required for evidence of the need for one.

8741 Public Participation

Comments:

The potential developers of Taylor Drive have carried out a consultation about the need for bungalows in this location.

8742 To consider planning.

To consider Withdrawal of RHM24564 and suggested sites

It was noted that RMBC have asked the developers to withdraw their application at the location next to The Butchers Arms.

A Working Group for the Parish Council has met and they recommended offering 4 alternative sites for the mast: Worksop Road, Recreation Ground, Opposite the proposed site, in the playground.

It was **resolved** to approve these recommended locations and enter discussions with the developers about them.

8743 To consider developing the Pavilion.

It was resolved to step outside standing orders and allow the Architects to make a presentation on this item.

It was agreed to keep this matter on each further agenda and to look at identifying grant funding.

8744 To consider information from the Communications working Group

The process of getting new signage for the Village is ongoing. The development of a new font and logo was deferred.

8745 To consider Play Ground equipment.

Playscape are visiting site on the 27th April and it was agreed that the council can receive any ideas from Councillors at the next meeting.

8746 To consider the Kings Coronation.

It was resolved that the Chair would make the public aware via social media that we would be issuing a "Commemorative Medal and not holding an event".

8747 To consider Speed Indicator Signs in the village.

It was resolved that Councillor Thomas be authorized to contact Westcotec about collecting the data from the devices and then in turn be allowed to collect said data for the Parish Council.

Cricket Pitch:

2020, 4 matches, multiple training dates which we cannot quantify

2021, 8 matches, multiple training dates which we cannot quantify

2022, 8 matches, multiple training dates which we cannot quantify

Councillor Baum-Dixon commented that there has been some positive results from the Wattsap group targeting rural crime.

Email from TARA noted and it was agreed that Councillor Clarke be the contact with this group on behalf of the Parish Council.
